Reimbursements will be paid in November 2019, February 2020 and May 2020 and there is - **NO LIMIT to the number of claims a club can make before 30th June 2020!**

The Institute offered tools to enable leaders (District Governors, Vice District Governors, Zone Chairmen and Club Presidents) to lead their Districts and Clubs in a strong confident manner. The participants who attended were from Australia and New Zealand, so it was good to get some new ideas from those across the ditch (or should I say both ditches). I hope to be able to bring some of the learnt leadership skills and ideas to the fore within our District.

On the media front, I apologise for not doing very much over the past month. There has been no internet coverage for me from 29th October until 14th November, so life had become very restricted. The mobile phone the only way of catching up on what was going on. In the new year I hope to get up and going again. Recommended sell price of \$20 (GST inclusive), although we emphasise that, other than for direct online sales, Lions Clubs may sell cakes at any price of their choosing. (**NB** – This cost price is not displayed on our website as it is confidential to Lions Clubs).

Change the world one community at a time

oao Pedro has just been diagnosed with bone cancer and wasn't sure if he would see his 13th birthday. When the day came he was surprised when hospital staff arrived in his room with a birthday cake. He had just started chemotherapy as an inpatient. It could have been a sad day but instead Joao's family, friends and hospital staff celebrated another year of life, something that perhaps had even more special meaning that year.

LCIF had provided a \$US98,900 grant to update and equip the paediatric cancer unit where Joao was receiving his treatment. Joao's father is quoted as saying "thank you for giving the hospital the opportunity to better serve children struggling with this invisible and often painful enemy. Many are winning the battle with the valuable assistance from Lions, Leos and LCIF". One of LCIF's new focus areas with Campaign 100 is childhood cancer. International Childhood Cancer Day is 15 February 2020. Does your community need support for anything relating to cancer particularly in children? February could be a good time to engage with your community to assess their future needs. Remember there are grants available from LCIF for any large projects that clubs undertake.
